Residential and Business Rebates

- Programs providing Citizens Gas customers rebates for high efficiency equipment
- Equipment must be purchased ON or AFTER October 1, 2008.
- Furnaces, Boilers, water heaters, ENERGY STAR® Programmable Thermostats, controls, boiler tune-ups, steam trap service, and pre-rinse sprayers
- Checks sent directly to customers
- Allow 6-8 weeks for processing

Easy Process

1. Complete the rebate form found at:
 - www.CitizensEnergySavers.com
 - or call 1-800-203-1856
 2. Include model, serial number and purchase date
 3. Attach a copy of the receipt and mail within 30 days of purchase
 4. A check will be mailed directly to the customer
- * The Wisconsin Energy Conservation Corporation (WECC) will be processing the rebates and provide program support

Note: If required data is missing a letter will be issued asking the customer to provide it



Application for Business Rebates

Please verify that the following requirements are met before submitting your application.

Rebate Requirements

1. Applicant must be a Citizens Gas General Heating or Non-Heating Delivery Service (Rates D3 and D4) natural gas customer and location of installed equipment or services performed must have Citizens Gas natural gas service. (Westfield area customers are not eligible.)
2. All applicable fields must be completed on the form to receive a rebate (installation address is required).
3. A copy of the customer's Invoice(s) must be stapled to the back of this form.
4. Equipment must be purchased October 1, 2008 or later. The rebate form and invoice(s) must be postmarked within 90 days of the equipment purchase or service. (Rebate funds are limited and available on a first-come, first-served basis.)
5. An eligible customer may receive a rebate for each eligible piece of equipment installed or service performed.
6. Please allow up to eight (8) weeks to receive your rebate. Incomplete rebate forms will not be processed.
7. Mail the signed, completed form and itemized invoices within 90 calendar days of installation to:

* Citizens Gas rebate may be up to 25% of the purchase price, excluding tax and installation costs, but will not exceed the maximum rebate amount. Must provide a copy of the manufacturer's cut-sheet, which must include the combustion efficiency or AFUE rating.
 ** Business must utilize natural gas for all space heating needs.
 *** Please visit www.CitizensEnergySavers.com for a list of water heaters that meet the Energy Factor requirement.
 **** Primary use must be space heating. Multiple boilers in a series and boilers used for domestic water heating are not eligible for the prescriptive program but may be eligible for the Custom Business Program.

Program Eligibility

- Active Residential and Commercial customers on rates D1, D2, D3 or D4 (Res. Domestic, Res. Heat, Gen. Non Heat, Gen. Heat)
- Westfield customers are not eligible
- Equipment must be purchased **ON** or **AFTER** program start date which was October 1, 2008
- Customer must use natural gas as primary heating source to redeem furnace rebates
 - Dual fuel systems, heat pumps with natural gas furnace back-ups, are **NOT** eligible for a furnace rebate
- Rebates for some equipment may be limited to 4 per household (Programmable Thermostats and furnaces)
- Customer must install equipment in single family homes, rental buildings with 3 units or less, or commercial buildings

Citizens Gas Business Custom Program

- The CitizensEnergySavers Business Custom Program will provide up to \$25,000 in grants for businesses investing in projects to reduce natural gas consumption that are not covered by the Prescriptive rebate program.

Business Custom Program

–Examples of eligible projects:

- Heat recovery projects
- HVAC or Domestic Hot Water (DHW) system control projects
- Insulation
- Infrared Heaters

–Grants proportional to estimated savings

- Savings ≤ 7500 therms will pay \$0.50/therm
- Savings $7500 \geq$ therms will pay \$1.00/therm
- Grant equal up to **30%** of project cost; maximum of **\$25,000**

Business Custom Program:

- Partnered with *Design-Aire Engineering* to provide eligibility screening, outreach and technical support
 - All projects must be screened for participation
 - Can assist with calculations of energy savings.
